Contest Rules

Break out your smartphones and video cameras! The Illinois Bicentennial is excited to offer high school and college students across the State the opportunity to showcase their creative talents and the incredible history and people of Illinois through its “Something to Learn About Illinois History” Video Contest.

Students across Illinois can enter the contest by submitting a 45 to 60 second, original, self-made video (horizontal/landscape format preferred) highlighting and describing “Something to Learn About Illinois History.” The video can describe a fact, a person, a place, or an event in Illinois history. In order to be eligible to participate, an entrant must be a high school or college (post-secondary) student in Illinois during calendar year 2017 and be 14-years-old or older on their date of entry. The Contest is only open to legal residents of Illinois in an Illinois high school or students, whether Illinois residents or not, registered in a university, college, community college, or technical school in Illinois.

100 winning videos will be chosen and may be aired as a piece of the campaign with WGN Radio and the State Journal Register (media entities) and through the Bicentennial social media platforms counting down 100 days until the Bicentennial. A new winning video may be chosen to be aired each day, and winners will be selected on a rolling basis.

- JUDGING:** A committee of judges, including a state historical official, will judge the entries based on; presentation of history, accuracy, interest, creativity and quality. Winners will be selected at the sole discretion of the judges. The Executive Director of the Office of the Illinois Bicentennial will receive copies of the scoring sheets at the conclusion of judging.
- COMPETITION REQUIREMENTS:** Entrants may submit only one entry per email address. Entrants must provide all information requested. The Entry must be submitted as a 45-60 second video and must be the sole original work of the Entrant. Entries must include a completed entry form and must be uploaded at www.illinois200.com.
- ANNOUNCEMENT OF WINNERS AND PRIZES:** Winner(s) will be notified by email and/or telephone by November 7, 2017. If Winner(s) cannot be contacted, and fails to claim within 15 days of notification, the prize may be forfeited. The winning submission will remain the property of the State of Illinois and may be used as part of the campaign. Winners will be selected on a rolling basis during the entry period; July 17 through August 31, 2017. Some winners will be chosen as early as July 31 while others not until September 30.

5. The winners of the contest will receive two tickets to the Chicago performance of "Hamilton: An American Musical" on December 3, 2017. No cash or other prize substitution shall be permitted except at the discretion of Celebrate Illinois Bicentennial-Illinois Chamber Foundation. The prize is non-transferable. Any and all prize related expenses, including without limitation any and all federal, state or local taxes, shall be the sole responsibility of Winner. Winners under the age of 18 must be accompanied by an adult (18 years of age or older).
